## NWSA Invited to National Wildland Fire Leadership Meeting

NWSA was invited by the National Fallen Firefighters Foundation to participate in the National Wildland Fire Leadership Meeting in April. Claren Nilsson, NWSA Vice President attended this meeting. The goal of the meeting was to engage in discussion on the types of strategies and tactics that will result in measurable reductions in line-of-duty deaths, accidents and injuries. Claren presented on behalf of the Professional Wildland Fire Services and in that she stated, "We are all firefighters, and I believe that in any presentation about the fallen it should have Professional Private Wildland Fire Service behand the name of the fallen, not contractor. We are not plumbers or electricians, we are firefighters killed in the line of duty."


